<sup>1</sup> Most health funds reimburse patients for therapy. Contact the fund to determine whether and how much they reimburse. If you are entitled to some reimbursement, the invoice/receipt you receive at the session is sufficient for the health fund. If sessions are part of a **GP's Mental Health Treatment Plan** or **Psychiatrist's Assessment and Management Plan**, there is a generous rebate available through Medicare (about \$130). In these cases you only claim *either* through your health fund or Medicare. Although the Australian Psychological Society's *Recommended Fee* is \$246 per session, I maintain my clinical fee below their suggestion.
